The Board may refuse to issue a license to an applicant who has been convicted of an offense or disciplined by a dental licensing body in a manner that bears, in the judgment of the Board, a demonstrable relationship to the ability of the applicant to practice dentistry in accordance with the provisions of the Dental practice Act, or who has falsified an application for licensure, or any person for any cause described under ORS 679.140 or 679.170.

## **Oregon State Requirements - DANB**

(1) Notwithstanding any other provision of this chapter, the Oregon Board of Dentistry shall issue a dental instructor's license to practice dentistry to any person who furnishes the board with evidence satisfactory to the board that the applicant meets the requirements of subsection (2) of this section.
